#### A. ALL INDIA QUOTA PRIVATE SEATS

State/UT Counseling Authorities have to conduct counseling for admission in 15% of AIQ-UG&PG seats under Private AYUSH colleges/institutes/Private State Universities (other than Deemed Universities) in adherence with guidelines-I schedule provided by the AACCC, Ministry of AYUSH to avoid the overlapping Schedule of AACCC-UG/PG counseling and State/UIT-UG/PG counseling

(Ref: - BUSS/NEET(UG)/2023 Dated 03.08.2023 NCISM, Ministry of AYUSH, Govt. of India)

RULES TO BE FOLLOWED FOR ALL INDIA QUOTA PRIVATE SEATS FOR ADMISSION IN UG/PG COURSES FOR ACADEMIC YEAR 2023-24:

(Ref: - File No. 3-97/2023/NCH-HEB-AACCC/8468-8481 Dated-27.10,2023 Ministry of AYUSH, Govt. of India)

- 1. Seat under all India quotas will be open in nature and there shall not be any requirement for domicile in a particular State/UT or passing of 10+2 in a particular State/UT.
- 2. State/UT counseling authorities shall conduct 02 Rounds for all India quota private seats and after 02nd Round, in case of remains vacant seats convert these seats into the State/UT quota.
- 3. Other criteria will be remained same as for All India quota seats as mentioned on <a href="https://aaccc.gov.in/">https://aaccc.gov.in/</a>

Note: - Candidates of Rajasthan domicile is also eligible for All India quota seats in private institutions subject to their all-India merit of AIAPGET-2023

#### (Ref. AIAPGET/BUSS/2023 fi/Dated: 06.09.2023, Ministry of AYUSH, Govt. of India)

- State/UT counseling authorities shall conduct 2 Rounds of counseling for admission in 15%
  All India Quota (AIQ) UG/PG seats of Private AYUSH Institutes/ Private State Universities
  (other than Deemed Universities). The AIQ seats that remain vacant after the second round of
  counseling may be converted to the State/UT Government quota seats, and the same shall be
  filled up in further rounds as per norms/ rules.
- 2. State/UT counseling authorities should give wider publicity among NEET (UG) 2023/AIAPGET-2023 qualified AYUSH UG & PG aspirants regarding the registration process of counselling & provide sufficient time for registration before each round of counseling for admission in AIQ-UG & PG seats of Private AYUSH Institutes.
- 3. State/UT may decide an all-inclusive Application Cost Non-refundable Registration Fee for counseling for admission in AYUSH-UG & PG seats for all category students. However, the maximum ceiling limit for this fee will be Rs 2000/-
- 4. State/UT may decide on refundable security money, which will be refunded to candidates after joining the allotted college or if the candidate did not get any seat during counseling. However, the maximum ceiling limit for this fee will be Rs. 50,000/- for UG & PG seats.
- 5. The Security money will be forfeited if a candidate does not join the allotted seat of Round-2 or Surrender/withdraw the seat allotted in Round-2 based on the candidate's request Further, the Security money will also be forfeited if the allotted seat of Round-2 is cancelled due to any unforeseen reason from the candidate's end. For example, the candidate gives wrong information at the time of registration on the basis of which a seat may be allotted and later cancelled by the Admission Authorities at the time of reporting or fails to produce the required documents at the time of admission (within the stipulated time).
- 6. No domicile certificate is required for allotment of AIQ-UG & PG seats of Private AYUSH Institutes.
- 7. Reservation for allotment of 15% AIQ-UG & PG seats in Private AYUSH Institutes: all AIQ-UG & PG seats of Private AYUSH Institutes are open in nature. However, as mentioned in relevant regulations, the relaxation in qualifying criteria may be provided category-wise.

#### A. General Information

- 1. Candidates can apply for registration for PG Admission counselling 2023 in "Online" mode only. Submission of Online Application Form may be done by accessing counselling board website <a href="www.rajugpgayushcounselling.in">www.rajugpgayushcounselling.in</a> The Application Form other than online mode will not be accepted in any case. Only one application is to be submitted by single candidate.
- 2. Candidates must follow the instructions strictly as given in the Information booklet available on counselling board website. Candidates not complying with the instructions shall be summarily disqualified
- 3. Candidates must ensure that e-mail address and Mobile Number provided in the Online Application Form are their own as all information/communication will be sent by counselling board on your e-mail address or SMS on given Mobile Number only

  - ❖ Download Information booklet and read these carefully to ensure your eligibility.
  - Follow the 4 steps given below to Apply Online:
    - **Step-1:** Fill in the Online Application Form and note down the system generated Application number.
    - **Step-2:** Upload scanned images of Candidate's Photograph, Domicile Certificate, Caste Certificate (if applicable), Secondary Mark sheet, Senior Secondary Mark sheet, Mark sheets of B.A.M.S. #### Note: -

- **A.** The final submission of Online Application Form will remain incomplete if Step-2 and step-3 are not completed. Such forms will stand rejected and no correspondence on this account will be entertained.
- **B.** No request for refund of fee once remitted by the candidate will be entertained by counselling board under any circumstances.
- **C.** The entire application process of PG counselling is online, including uploading of scanned images, Payment of Fees, and Printing of Confirmation Page. Therefore, candidates are not required to send/submit any document(s) including Confirmation Page to Counselling Board through Post/ Fax/ By hand.
- **D.**Candidates are advised to **keep visiting the Counselling Board website regularly** for latest updates.

#### 2. Registration Fee

- **A.** All candidates are required to deposit registration fee of Rs. 2000/- (for General, EWS & OBC candidates) and Rs.1500/- (for SC/ST candidate of Rajasthan state domicile) through Internet banking / Debit card / Credit card. The registration fee is neither refundable, nor transferable and nor adjustable for any future State PG admissions. Any plea in this matter shall not be entertained. Please keep the information submitted in application form confidential and do not share with anybody. If you don't register during registration period, you will not be allotted any seat. only one registration of a candidate will be entertained for whole process of counselling.
- **B.** AIAPGET-2023 qualified candidates may apply for counselling and admission to Ayurveda PG Institutions in Rajasthan only, if eligible based on applicable rules, regulations, reservation policy and other criteria specified by Govt. of India/ Govt. of Rajasthan respectively.
- **C.** Counselling Board will propose its own merit list considering AIAPGET-2023 merit list and based on its applicable rules regulations, reservation policy and other criteria.
- **D.** Counselling will be conducted *online*. Merit list will be prepared on the basis of registered eligible applicants as per rules. All admission will be made to the meritorious candidates as per rules of counselling

#### 3. General Instructions, Terms and Conditions

- **A.** Applicants may note that appearance in PG Counselling 2023 does not confer any automatic rights to secure an admission in AYUSH Post Graduate MD/MS courses. The selection and admission to Postgraduate seats in any AYUSH institution(s) recognized for running MD/MS courses as per the NCISM Act is subject to fulfilling the admission criteria, eligibility, medical fitness and other criteria as prescribed by the respective universities, AYUSH institutions, NCISM, State/Central Government
- **B.** Online Registration process will be conducted as per time schedule available at website.
- **C.** Applications of candidates producing false or fabricated information will not be considered and such candidates may be debarred from appearing in any future counselling conducted by counselling board.
- **D.** Before initiating registration process, candidates should go through the Information Booklet carefully for eligibility criteria, scheme and pattern of counselling etc. Any queries and other issues will only be entertained if the requested information is not given in the Information Booklet.
- **E.** Incomplete application, if not in accordance with instructions, will not be considered and is liable to be rejected. Applicant should carefully fill up all the fields during registration process. **Application cannot be modified/edited at any circumstances.**
- **F.** Instructions in the Information-Booklet are liable to change based on decisions taken by the Constitutional Authorities.
- **G.** Counselling Board reserves the right to withdraw permission, if any, granted inadvertently to any candidate who is not eligible to appear in PG Counselling even though Registration number has been issued or is displayed on website
- **H.** Counselling Board does not verify the information provided by the candidates during online registration and hence candidature will be purely provisional subject to the fulfillment of eligibility criteria as mentioned in the Information Booklet for PG Counselling & criteria of NCISM/ State/Universities/Institutions concerned.
- I. Candidates must verify from the respective state government/ Universities and Institutes if at all they will be considered for admission to All India Quota (in private college). State Quota Post Graduate seats based on applicable regulations and /or domicile criteria, State/Institute of Graduation, reservation policy fee structure etc. Merely appearing in AIAPGET 2023 does not make a candidate qualified and/or eligible for All India quota (in private seats)/State Quota seats for admission.

#### RULES AND REGULATIONS OF ADMISSION IN PART-I OF AYURVEDA VACHASPATI/ DHANWANTARI – MD/MS (AYURVED) FOR ACADEMIC SESSION2023-24

#### 4. COMMON FEATURES

#### A. Qualification for Admission:

Ayurvedacharya Degree (Bachelor of Ayurvedic Medicine and Surgery) of Universities of Rajasthan State or any equivalent Degree recognized by NCISM/CCIM.

- (A) Candidates who have qualified in the AIPGET-2023 can participate in the counselling for admission in MD/MS(Ayurved) course for the academic year 2023-24.
- (B) Minimum qualifying marks for AIPGET-2023 will be as specified in existing PG Regulation (ASU) as given below:
- In order to be eligible for admission to postgraduate courses for an academic year, it shall be necessary for a candidate to obtain minimum of marks at 50th percentile in the All-India AYUSH Post Graduate Entrance Test, 2023 (AIAPGET-2023).

#### Provided that in respect of-

- (a) candidates belonging to the Scheduled Castes, Scheduled Tribes and Other Backward Classes, the minimum marks shall be at 40th percentile;
- (b) candidates with benchmark disabilities specified under the Rights of Persons with Disabilities Act, 2016 (49 of 2016), the minimum marks shall be at 45th percentile for the General Category and 40th percentile for the Scheduled Castes, Scheduled Tribes and Other Backward Classes.
- (C) NCISM has decided to reduce the minimum qualifying percentile criteria of EWS-PwD category by 5 percentile i.e. from 45th to 40th percentile in EWS-PwD category under Ayurveda, Siddha and Unani streams for academic year 2023-24 vide its letter No. <a href="Ref.No.-AIAPGET/COE/2023">Ref.No.-AIAPGET/COE/2023</a> Dated. 06.10.2023.
- **B.** Candidates: Must have completed the six- or twelve-months rotating Internship/House Job, as the case may be, after passing the qualifying examination by 31 October 2023 or as decided by The Ministry of AYUSH, Government of India.
- C. The online application form and time schedule are available on the Board website www.rajugpgayushcounselling.in

#### **D.** Counselling Procedure:

- i. Admission will be subject to the rules & regulation of the respective institutes.
- ii. Counselling Board reserves the right to correct any inadvertent error in any merit list and also in the prospectus.
- iii. The Counselling Board shall conduct online counselling of the candidates and allot the institute/college and Subjects taking into an account the scheme of distribution of reserved seats, merit lists of respective categories, the order of the merit of AIAPGET 2023, preference and availability of seats.\
- iv. Candidates must possess BAMS Degree or Provisional degree certificate recognized as per the provisions of the IMCC 1970/HCC 1973/ NCISM 2020 Act and possess permanent or provisional registration certificate issued by the CCIM/NCISM/ State Board, and must have completed a satisfactorily one-year compulsory rotating internship by **31st October 2023** as per the NCISM notification. (for the academic year 2023-24 only)

(Ref. AIAPGET/BUSS/2023 fi/Dated: 06.09.2023, Ministry of AYUSH, Govt. of India)

- v. Vacant seats arising due to any reason shall be filled by up-gradation on the basis of Reservations and Merit-cum-Preference List.
- vi. No TA/D.A. will be paid to the candidates for appearing in document verification after the allotment of seat in online counselling.

#### E. Counselling, Merit List, Subject Preference and Allotment:

i. The eligible candidates will be allotted seats in institutions through online process on the basis of provisional merit list, Category, Subjects wise available seats, preference provided by the candidate in choice filling format and based on the data/Information of eligible candidates from the National Testing Agency, i.e., the AIAPGET-2023 examination conducting body.

- ii. Candidate will have to deposit counselling fee Rs 30000/- (Rs Thirty Thousand only) through Net-banking/Credit Card/Debit Card by last date of choice filling till (As per Schedule available on website) and to submit choice filling Performa failing which their admission shall cancelled and they will not eligible to participate in counselling process.
- iii. Once seats and college are allotted to the candidate in 1st round of counselling, the candidate will have to report in person at allotted reporting center and deposit prescribed remaining college annual fee only through Online mode/Demand Draft in favor of CHAIRMAN, AYUSH UG ADMISSION COUNSELLING BOARD, JODHPUR, during stipulated period of time. This candidate will also be eligible for 2nd round of counselling for upgradation. if he/she fills fresh choice filling form for 2nd round.
- iv. If candidate doesn't report to the reporting center and doesn't deposit the prescribed remaining college annual fee with in stipulated period of time, his/her allotment will be cancelled and that seat will be treated as vacant seat. However, he/she may participate in 2nd round of counselling without forfeiting Counselling Fee as a last chance but he/she have to fill fresh choice filling form for 2nd round of counselling. For such candidates, seats will be allotted on availability of seats and on the basis of fresh merit list of round 2.
- v. After the allotment of 2<sup>nd</sup> round, candidates who got allotted seats will have an option to surrender his/her seat only within the duration of **three days** after date of allotment along with the condition of forfeiting his/her **Counselling fee** (**Security Money**) After the said period, candidates will not be allowed to withdraw/surrender their admitted seats of 2<sup>nd</sup> round. If they do so, they will be ineligible for any further AYUSH counseling conducted by Central/State/UT.
- vi. If candidate after getting seat allotment in 1<sup>st</sup> round or 2<sup>nd</sup> round fails to report at reporting centers at the office of Counselling Board, Jodhpur on due date and time, his/her seat allotment will stand cancelled and counselling fee will be forfeited and will not be refunded in any circumstances. He/she may participate in next round of counselling in case of vacant position if any, only after fresh deposit of counselling fee Rs. 30000/- (Rs Thirty Thousand only).
- vii. The counselling fee will be forfeited in case the candidate gives wrong information at the time of application on the basis of which a seat may be allotted and later cancelled by the Admission Authorities at the time of reporting.
- viii. Those who applied but not allotted a seat in first round as well as in second round will be considered for mop-up round of counselling (without fresh application form i.e., need not fill the application form again).
- ix. Candidates without original certificates/documents shall not be allowed to take admission to the allotted Ayurved College. Candidates who have deposited their original documents in any other Institute/College/University and come for admission with a certificate/undertaking stating that "original certificates are deposited with the Institute/College/University" or bring color photo copy of original documents shall not be allowed to take admission in allotted College.
- x. The Counselling Board shall provide the list of provisionally allotted candidates to the concerned college.
- xi. Candidates are advised to visit Counselling Board Website and daily newspapers time to time for information of dates and other information for participation in various rounds of counselling.
- xii. The Actual Admissions in a particular Institute will be subject to the rules and regulations of that Institute.
- xiii. In-Service-Candidates are directed to upload NOC (No Objection Certificate) along with submission of choice filling proforma and counselling fees. NOC must be issued by competent authority of Ayurveda department of Govt. of Rajasthan on or before last date of online submission. After last date of online submission NOC will not be accepted/entertained.
- xiv. Therefore, all in-service candidates must be very clear that they will get seat allocation only through online mode on their In-Service quota seats.
- xv. If the in-service seats remain vacant due to unavailability of in-service candidates, that vacant seat will be filled by the concern category of seats reserved for, from the non-Service candidate.

#### F. REPORTING TO COLLEGE AFTER COUNSELLING/JOINING TIME

- Each candidate shall be given the time as mentioned in the allotment letter, issued on line, to join the allotted college and course. There is no provision of extension for joining date under any circumstances. The allotment made will be firm and final. Change of college/course from one place to another is not permitted. Therefore, request for the same would not be entertained by the Counselling Board after the allotment, except the candidate can opt for 2nd round of counselling for change of college as per allotment.
- ii. While reporting for admission, please carry all the relevant certificates/documents in original and also submit an undertaking (Proforma-1) on (Non-Judicial Stamp of Rs 50) that the submitted documents are in original.
- iii. The selected candidates will be required to undergo medical examination at the allotted institution on the notified date(s).
- iv. Candidates who fail to attend medical examination on the notified date are liable to forfeit the claim for admission. Candidates who have been admitted must join their classes on the date to be notified.
- v. The allotment for this admission will be cancelled if the selected candidates do not report to the allotted college up to the stipulated date or whose particulars are not found correct or who are found medically unfit.
- vi. The selected candidates must also carry all requisite certificates and documents in original and also submit an undertaking that the submitted documents are in original along with 2 sets of printout of application form along with self-attested 2 sets of photocopies of the documents, at the time of reporting in Round 1/Round 2/mop-up round and shall deposit the applicable fees of the allotted college and complete other formalities within stipulated time, failing which their admission shall stand cancelled.
- vii. The non-viewing of the websites about allotment information by the candidate shall not be accepted as a ground for non-reporting on the scheduled time and date. The candidate's allotment will stand automatically cancelled if he/she does not report IN PERSON at the office of Counselling Board. Jodhpur, as per the notified schedule.
- viii. A candidate shall have to deposit the full fee (Remaining) of the college for the session 2023-24, only through Online mode/demand draft on reporting center at the office of Counselling Board within the notified time.

#### G. IMPORTANT

- i. The candidates who do not join the allotted college will be treated as fresh candidate in the subsequent round of counselling.
- ii. Admission will be cancelled if the selected candidates do not report to the allotted college and Deposit fees with in stipulated period.
- Note: 1. No admission will be done by UG PG AYUSH Counselling Board, Rajasthan after cutoff date decided by Ministry of AYUSH, Govt. of India, New Delhi.
  - 2. The candidates, who have been found ineligible by AACCC for participation in admission counselling process in any state/stage will not be eligible for participation in admission counselling being conducted by this Counselling Board.

#### H. Reservations, Subjects and Admission Capacity:

Subjects, Reservations & Admission Capacity are different in different Institutes.

- The distribution of seats in a particular institute will be as per the Rules & Regulations
  of the respective Institution and State Govt. of Rajasthan, Govt. of India and NCISM,
  New Delhi.
- Category wise reservation on AIQ seats will be given as per Hon'ble Supreme Court order dated 07.01.2023 on W.P. No. 961 of 2023
- Certain Seats are reserved for PH Candidates horizontally. These seats shall be filled from the Candidates belonging to the relevant PH Category on the basis of Merit.

## I. PwBD- 5% (Horizontal Reservation, i.e., 5% in each of OPEN, GEN-EWS, OBC-NCL, SC, and ST category seats

Provisions relating to Persons with Benchmark Disability (PwBD): As per Section 2(t) of the RPwD Act, "Persons with Benchmark Disability (PwBD)" means a person with long term physical, mental, intellectual, or sensory impairment which, in interaction with barriers, hinders his full and effective participation in society equally with others. According to Section 2(r) of the RPwD Act, 2016, "persons with benchmark disabilities" means a person with not less than forty percent (40%) of a specified disability where specified disability has not been defined in measurable terms and includes a person with disability where specified disability has been defined in measurable terms, as certified by the certifying authority. Disability certificate as per 21 Benchmark Disabilities given under RPWD Act 2016, from the designated disability Centers as per the list enclosed as **ANNEXURE II.** The certificate issued by any other hospital/board will not be accepted. Further, the format of 'Certificate of Disability' is attached in **Annexure-I** Seats
