A. General Information

1. Candidates can apply for registration for PG Admission counselling 2020 in “Online” mode only. Submission of Online Application Form may be done by accessing counselling board website www.rajugpgayushcounselling.in/https://rajayushcounselling.com The Application Form other than online mode will not be accepted in any case.
 2. Only one application is to be submitted by a candidate.
 3. Candidates must follow the instructions strictly as given in the Information booklet on counselling board website. Candidates not complying with the instructions shall be summarily disqualified
 4. Candidates must ensure that e-mail address and Mobile Number provided in the Online Application Form are their own as all information/communication will be sent by counselling board through e-mail on e-mail address or SMS on given Mobile Number only
 - ❖ Instructions for filling Online Application Form
 - ❖ Download Information Booklet and read these carefully to ensure your eligibility.
 - ❖ Follow the 4 steps given below to Apply Online:
 - Step-1:** Fill in the Online Application Form and note down the system generated Application Number
 - Step-2:** Upload scanned images of Candidate’s Photograph, Domicile Certificate, Caste Certificate (if applicable) Secondary Mark sheet, Senior Secondary Mark sheet, Mark sheets of B.H.M.S. (1st to Final), Internship Certificate, Registration Certificate, AIAPGET 2020 Admit Card, and AIAPGET-2020 Mark sheet in JPG/JPEG format.
 - Step-3:** Make payment of fee using appropriate payment mode through appropriate payment gateway and keep proof of fee paid.
 - Step-4:** Print at least two copies of Confirmation Page after successful remittance of fee.
- ❖ **All the 4 Steps can be done together or at separate times.**

Note:-

1. The final submission of Online Application Form will remain incomplete if Step-2 and step-3 are not completed. Such forms will stand rejected and no correspondence on this account will be entertained.
2. No request for refund of fee once remitted by the candidate will be entertained by counselling board under any circumstances.
3. The entire application process of PG counselling is online, including uploading of scanned images, Payment of Fees, and Printing of Confirmation Page. Therefore, candidates are not required to send/submit any document(s) including Confirmation Page to Counselling Board through Post/ Fax/ By hand.
4. Candidates are advised to **keep visiting the Counselling Board website regularly** for latest updates.

2. Registration Fee:

- 2.1 All candidates are required to deposit registration fee of Rs. **2000/-** (for General & OBC candidates) and Rs. **1200/-** (for SC/ ST candidate of Rajasthan state domicile) through Internet banking / Debit card / Credit card. The registration fee is neither refundable, nor transferable and nor adjustable for any future State PG admissions. Any plea in this matter shall not be entertained. Please keep the information submitted in application form confidential and do not share with anybody. If you don't register during registration period, you will not be allotted any seat. Please also note that registration will be available once only.
- 2.2 AIAPGET-2020 qualified candidates may apply for counselling and admission to Homeopathy PG Institutions in Rajasthan, if eligible based on applicable rules, regulations, reservation policy and other criteria specified by Govt. of India/ Govt. of Rajasthan respectively.
- 2.3 Counselling Board will propose its own merit list considering AIAPGET-2020 merit list and based on its applicable rules regulations, reservation policy and other criteria.
- 2.4 Counselling will be conducted **online** merit list will be prepared on the basis registered eligible applicants as per rules which will be displayed at the website informed by website. All admission will be made to the meritorious candidates as per rules of counselling.

3. General Instructions, Terms and Conditions

- (i) Applicants may kindly note that appearance in PG Counselling 2020 does not confer any automatic rights to secure an AYUSH Post Graduate MD/MS. The selection and admission to Postgraduate seats in any AYUSH institution(s) recognized for running MD/MS courses as per the CCH Act is subject to fulfilling the admission criteria, eligibility, medical fitness and other criteria as may be prescribed by the respective universities, AYUSH institutions, CCH, State/Central Government.
- (ii) Online Registration process will be conducted as per time schedule available at website.
- (iii) Applications of candidates producing false or fabricated information will not be considered and such candidates may be debarred from appearing in any future counselling conducted by counselling board.
- (iv) Before initiating registration process, candidates should go through the Information Booklet carefully for eligibility criteria, scheme and pattern of examination etc. Any queries and other issues will only be entertained if the requested information is not given in the Information Booklet.
- (v) Incomplete application, if not in accordance with instructions, will not be considered and is liable to be rejected. Applicant should carefully fill up all the fields during registration process. Application cannot be modified/edited at any circumstances.
- (vi) Instructions in the Information-Booklet are liable to change based on decisions taken by the Constitutional Authorities.
- (vii) Counselling Board reserves the right to withdraw permission, if any, granted inadvertently to any candidate who is not eligible to appear in PG Counselling even though Registration number has been issued or is displayed on website.
- (viii) Counselling Board does not verify the information provided by the candidates during online registration and hence candidature will be purely provisional subject to the fulfillment of eligibility criteria as mentioned in the Information Booklet for PG Counselling & criteria of CCH/ State/Universities/Institutions concerned.

- (ix) Candidates must verify from the respective state government/ Universities and Institutes if at all they will be considered for admission to All India Quota (in private college). State Quota Post Graduate seats based on applicable regulations and /or domicile criteria, State/Institute of Graduation, reservation policy fee structure etc. Merely appearing in AIAPGET 2020 does not make a candidate qualified and/or eligible for All India quota (in private seats)/State Quota seats for admission.

RULES AND REGULATIONS FOR ADMISSION COUNSELLING IN Part-I of M.D. (Homoeopathy) Course FOR THE ACADEMIC SESSION 2020-21

COMMON FEATURES

1. Qualification for Admission:

1.1 Homoeopathy Degree (Bachelor of Homoeopathy Medicine & Surgery) of Universities of Rajasthan OR any equivalent examination recognized by CCH New Delhi.

1.2 No candidate shall be admitted to M.D. (Homeopathy) course unless he possesses the degree of:-

- i. Bachelor of Homoeopathic Medicine and Surgery or equivalent qualification in Homoeopathy included in the Second Schedule to the Act, after undergoing a course of study of not less than five year and six months duration including one year compulsory internship; or
- ii. Bachelor of Homoeopathic Medicine and Surgery (Graded Degree) or equivalent qualification in Homoeopathy include in the Second Schedule to the Act, after undergoing a course of study of not less than two years' duration.
- iii. Candidates who have qualified in the AIPGET-2020 can participate in the counselling for admission in MD course for the academic year 2020-21.
- iv. Minimum qualifying marks for AIPGET-2020 will be as specified in existing PG Regulation (ASU) as given below:

“The qualifying criteria for AYUSH MD courses shall be as per CCIM/CCH and Ministry of AYUSH, Govt of India directions i.e. Indian Medicine Central council (Post Graduate Ayurveda Education) Amendment Regulation 2018, In order to be eligible for admission to post-graduate courses for an academic year, it shall be necessary for a candidate to obtain minimum marks at 50th percentile in the AIAPGET 2020. Qualifying criteria for candidates belonging to scheduled castes, scheduled tribes and other backward classes, the minimum marks shall be at 40th percentile. Candidate with benchmark disabilities specified under the Rights of Persons with Disabilities act, 2016 (49 fo 2016) the minimum marks shall be at 45th percentile for General category and 40th percentile for scheduled caste, scheduled tribes and other backward classes.”

1.3. Candidates must have completed the Twelve months rotating Internship /House Job, as The case may be, after passing the qualifying examination as stipulated by date **31 December 2020** or as decided by Ministry of AYUSH, Government of India.

1.4. The online application form and prospectus will be available on the Board website www.rajugpgayushcounselling.in/https://rajayushcounselling.com

2. Counselling Procedure:

- 2.1** Admission will be subject to the rules & regulations of the respective institutes.
- 2.2** Counselling Board reserves the right to correct any inadvertent error in any merit list and also in the prospectus.
- 2.3** The Counselling Board shall organize counselling of the candidates and allot the Institute and Subjects taking into an account the Scheme of distribution of reserved seats, Merit lists of respective categories, the order of the Merit of AIAPGET 2020 Preference and Availability of seats.
- 2.4** The right of admission of any candidate who does not complete the prescribed internship by date 31 December 2020 or as decided by Ministry of AYUSH, Government of India, will automatically stands cancelled.
- 2.5** Vacant seats due to any reason shall be filled by reshuffling on the Basis of Reservations and Merit-cum-Preference List from the candidates in the Waiting.
- 2.6** No TA/D.A. will be paid to the candidates for appearing in the Counselling.

3. Selection of Candidates for Admission: Selection of the candidates shall be made strictly on the basis of AIAPGET-2020 Merit.

4. Counselling, Merit List, Subject Preference and Allotment:

- i. The candidates will be allotted seats in institutions through online process on the basis of provisional merit list, Category, Subjects wise available seats and preference provided by the candidate in choice filling format.
- ii. For equal marks in AIAPGET-2020, the final merit will be decided at the time of counselling on the basis of BHMS Marks; therefore candidate must fill-up his BHMS marks in application form. In case there is tie of the marks in AIAPGET-2020 merit list preference will be given to the candidate passing BHMS examination in first attempt in the higher percentage of the marks. If a tie still exists, the allotment shall be made giving preference to seniority in age.
- iii. After declaration of provisional merit list, candidate will have to deposit counselling fee Rs 30000/- (Rs Thirty Thousand only) through Net-banking/Credit Card/Debit Card by last date of choice filling till 7.00 PM and to submit choice filling performa failing which their admission shall cancelled and they will not eligible to participate in counselling process.
- iv. After allocation of seats in 1st round candidate must report at the office of Counselling Board, Jodhpur in person and will submit all requisite certificates and documents in ORIGINAL along with 2 sets of self attested copies of the same for verification at the time of reporting with prescribed college fees applicable as per prevailing provisions of concerned institution/university. Therefore candidates are directed to go through fee structure of all Govt. /Private institutions/Universities of Rajasthan as this is not under purview of counselling board.
- v. Candidates once allotted seat and college in 1st Round, must deposit their full fee for the session 2020-21 at the office of Counselling Board, Jodhpur within stipulated period of time. Only then they will be eligible for up gradation in 2nd round if they desire so to change college/Subject. Seats allotted to the candidates up to the 2nd round will be considered as final and there will be no chance for them to participate for further round of counselling.
- vi. A candidate allotted a seat in second round of counseling and does not report/ join the allotted seat, his/her counselling fee will be forfeited. Such candidate shall not be eligible to participate in subsequent round.
- vii. If candidate after getting seat allotment in 1st round or 2nd round fails to report at reporting centers at the office of Counselling Board, Jodhpur on due date and time, his/her seat allotment will stand cancelled and counselling fee will be forfeited and will not be refunded in any circumstances. He/she may participate in next round of counselling in case of vacant position if any, only after fresh deposit of counselling fee Rs. 30000/- (Rs Thirty Thousand only).
- viii. The counselling fee will be forfeited in case the candidate gives wrong information at the time of application on the basis of which a seat may be allotted and later cancelled by the Admission Authorities at the time of reporting.

- ix. No candidate will be allowed to resign from the State Quota seats after allotment in 2nd round.
- x. Those who applied but not allotted a seat in first round as well as second round will be considered for mop-up round of counselling (without fresh application form i.e. need not fill the application form again).
- xi. A candidate without Original certificates/documents shall not be allowed to take admission at the time of reporting at the office of Counselling Board, Jodhpur under any circumstances. A candidate who has already been admitted in PG course and has deposited his/her certificates in any college/institute/university and comes for counselling (allotment process) with a certificate stating that "his/her original certificates are deposited with the another reporting centers/college/institute/university, will also be allowed to take admission at the allotted college subject to production of ORIGINAL certificate issued by concerned Counselling Board/Head of the institution to this Counselling Board during his/her counselling, stating that the original documents of the candidate are deposited with them..
- xii. The counselling board shall provide the list of provisionally allotted candidates to the concerned college.
- xiii. Candidates are advised to visit counselling board website and daily news papers time to time for information of dates and other information's for conducting various rounds of counselling.
- xiv. After mop-up round, once the AACCC AIAPGET-2020 merit list is exhausted and vacant seats thereof are transferred to Counselling Board Rajasthan, the admissions on residual vacant seats will be done on filling application form with NEET UG/PG AYUSH Counselling Board Rajasthan in Stray Vacancy Round if needed.
- xv. The Actual Admissions in a particular Institute will be subject to the rules and regulations of that Institute.

5. REPORTING TO COLLEGE AFTER COUNSELLING/JOINING TIME

- i. Each candidate shall be given the time as mentioned in the allotment letter, issued on line, to join the allotted college and course. There is no provision of extension for joining date under any circumstances. The allotment made will be firm and final. Change of college/course from one place to another is not permitted. Therefore, request for the same would not be entertained by the Counselling Board after the allotment, except the candidate can opt for 2nd round of counselling for change of college as per allotment.
- ii. While reporting for admission, please carry all the relevant certificates/documents in original and also submit an undertaking (Proforma-1) on (Non Judicial Stamp of Rs 50) that the submitted documents are in original.
- iii. The fact that a candidate has appeared for allotment shall not entitle him/her for allotment reallocation as the same will be subject to availability of seat and acceptance of the available seats at the rank of the candidate by him/her.
- iv. The selected candidates will be required to undergo medical examination at the allotted institution on the notified date(s).
- v. Provided that if any candidate is not able to report for Medical Examination at the Institution on the notified date on medical grounds or due to some other circumstances beyond his/her control and his/her parent/guardian comes in person on his/her behalf for verification of the original certificates to the college he/she will be considered for provisional admission. His / Her formal admission will be confirmed only when he/she is found medically fit and fulfills other requirements as per the dates notified.
- vi. Candidates who fail to attend medical examination on the notified date are liable to forfeit the claim for admission. Candidates who have been admitted must join their classes on the date to be notified.
- vii. The selection for this admission will be cancelled if the selected candidates do not report to the allotted college and deposit fees upto the stipulated date or whose particulars are not found correct or who are found medically unfit.
- viii. The selected candidates must also carry all requisite certificates and documents in original and also submit an undertaking that the submitted documents are in original along with 2

sets of printout of application form along with self-attested 2 sets of photocopies of the documents, at the time of reporting in Round 1, at the time of counseling of Round 2 and mop-up round and shall deposit the applicable fees of the allotted college and complete other formalities within stipulated time, failing which their admission shall stand cancelled.

- ix. The candidates must present the accepted resignation/relieving letter from the institution he/ she is pursuing studies at present, at the time of reporting. Failure to do so will result in disqualification for admission.
- x. The non-viewing of the websites about allotment information by the candidate shall not be accepted as a ground for non-reporting on the scheduled time and date. The candidate's allotment will stand automatically cancelled if he/she does not report IN PERSON at the office of Counselling Board, Jodhpur, as per the notified schedule.
- xi. A candidate shall have to deposit the full fee of the college for the session 2020-21, only through demand draft on reporting center at the office of Counselling Board within the notified time after the counselling.

6. IMPORTANT

- i. The candidates who do not join the allotted college will be treated as fresh candidate in the subsequent round of counselling.
- ii. Admission will be cancelled if the selected candidates do not report to the allotted college and Deposit fees with in stipulated period.

7. Reservations, Subjects and Admission Capacity:

7.1 Subjects, Reservations & Admission Capacity are different in different Institutes. The distribution of seats in a particular institute will be as per the rules & regulations of the respective Institution and State Govt. of Rajasthan, Govt. of India and CCH, New Delhi.

7.2 Certain Seats are reserved for PH Candidates horizontally. These seats shall be filled from the Candidates belonging to the relevant PH Category on the basis of Merit.

Note for Orthopedic Physically Handicapped PH Seat as per Seat Matrix:

- I. Candidate must possess a valid document certifying his/her physical disability conforming to judgments of Supreme Court of India i.e. with the approval of the Ministry of Health & Family Welfare, Govt. of India vide letter no.18018/ 2/ 2009-ME (P-1) dated 17.02.2009 it has been decided that while providing reservation in admission to medical course in the first instance candidates with disability of lower limbs between 50% to 70% shall be considered and in case candidates are not available of such candidates in that category then the candidates with disability of lower limbs between 40% to 50% will also be considered for admission subject to the outcome in the Writ Petion (Civil) 184/2005-Dr. Kumar Sourav Vs. UOI & others is pending in the Supreme Court of India.
- II. The disability certificate should be produced by a duly constituted and authorized Medical Board of the State or Central Govt. Hospitals/Institutions. The certificate should **not be older than three months of the counselling dates.**

10.Reservation:-

Provision of reservation for candidates of Rajasthan belong to specific category will be in accordance of rules and regulations enforced by the Govt. of Rajasthan.

11. Admission in the PG Courses of AYUSH Colleges in Rajasthan shall be available subject to approval by CCIM and Ministry of AYUSH Govt. of India, Govt. of Rajasthan and Affiliating University concerned.

12.Character/Conduct

Candidates should bring the Character/Conduct Certificate in the prescribed form at the time of Counselling/interview. Admission of candidate whose character has not been found satisfactory during the degree course is liable to be rejected.

13.Miscellaneous:

- The preference given by the candidate with respect to institute/subject at the time of submission of Form/Counselling will be final and no change will be allowed subsequently.
- The Admission Form will be considered for the MD (Homoeopathy) Part-I only for the Session and Year the candidate applies for.
- Admission will be granted subject to being declared Medically Fit by a duly Constituted Body by the concerned Institute.
- The Board reserves the right to accept or reject any Application Form or to amend any rule and regulation or cancel any admission without assigning any reason thereof.
- The original documents of the admitted candidates will remain with the Institute till completion of the Course.
- Any dispute will be subject to Jodhpur Jurisdiction only.
